FORD COUNTY BOARD MINUTES April 13, 2015

CALL TO ORDER:

The County Board of Ford County met pursuant to adjournment in the Ford County Board Room of the Ford County Jail in Paxton on Monday, April 13, 2015 at 7:00 p.m. The meeting was called to order by County Board Chairman, Randy Berger.
