

FORD COUNTY BOARD MINUTES

September 8, 2014

A. CALL TO ORDER:

The County Board of Ford County met pursuant to adjournment in the Ford County Board Room of the Ford County Jail in Paxton on Monday, September 8, 2014, at 7:00 p.m. The meeting was called to order by County Board Chairman, Rick Bowen.

Treasurer Hastings presented her report. The county has a balance of \$180,295.83 as of August 30, 2014. The real estate tax deadline was last Friday, September 5. As of September 22, no personal checks may be written to pay taxes. The tax sale is scheduled for October 22.
