## G. COMMENTS FROM THE FLOOR:

Kirk Allen, from Kansas, IL., who is a co-owner of the Edgar County Watchdogs, said that on February 4, 3 people begged for help in regard to keeping the people from the Ford Iroquois Public Health Dept. accountable for their spending actions. He read a statement explaining the disclosures that were found. He challenged the board to prove that his reporting was incorrect.

Mr. Doug Corbett, Ford Iroquois Public Health Department administrator, was asked questions by board members in regard to the accusations in regard to FOIA and the bids for the solar panels. States Attorney, Matt Fitton, advised that there is pending litigation in regard to the FOIA documents and that the board needs to be very careful with their questions. Mr. Corbett said that they have been working on the FOIA requests and he feels that he did nothing wrong in regard to how he handled the solar panel bids.
