RESOLUTION 24 -

WHEREAS, the Employee Policy Manual was last adopted on February 14, 2022, as Resolution 22 – 22; and

WHEREAS, the Employee Policy Manual may be amended by the Ford County Board, at its discretion, at any duly constituted regular County Board meeting; and

WHEREAS, a Paid Leave Act Policy effective January 1, 2024, requires employers to adopt said policy; and

BE IT HEREBY RESOLVED that the Ford County Board adopts the following language to be added to the Employee Policy Manual adopted as Resolution 22 – 22 on February 14, 2022, effect January 1, 2024:

Paid Leave Act Policy

Accruals and use. Employees will be able to earn and use a minimum of 40 hours of paid leave during a 12-month period. Paid leave will accrue at a rate of one hour for every 40 hours worked and may be used for any purpose. Overtime-exempt employees will be deemed to work 40 hours each workweek unless their regular workweek is fewer than 40 hours. Employees will not have to give a reason for the leave, and Elected Officials/Dept. Heads will not be able to require documentation or certification for the leave.

Timing. Paid leave will begin accruing on the first day of employment or Jan. 1, 2024, whichever is later. Employees will be able to use paid leave 90 days after accruals begin. Employees will have the choice to use paid leave under this law before using any other leave provided by the employer or state law. In other words, the Elected Officials/Dept. Heads cannot require an employee to exhaust some other paid leave before using leave under this law. If a former employee is rehired within 12 months, all previously accrued but unused paid leave must be reinstated and made available for immediate use.

Notice. Employees will be able to request leave in writing or orally in accordance with the employer's reasonable notification requirements. Elected Officials/Dept. Heads will require seven calendar days' notice for foreseeable leaves. For unforeseeable leaves, employees will have to provide notice as soon as practicable. Elected Officials/Dept. Heads will have to give employees written documentation of any required notice procedures.

Pay. Employees will receive their hourly pay rate while on leave. Elected Officials/Dept. Heads will not have to pay out unused paid leave on employment separation unless the paid leave is credited to an employee's paid time off (PTO) bank or vacation account, as required by the Illinois Wage Payment and Collection Act and rules.

Resolution 24-

Resolution Allowing the Ford County Engineer to Continue Serving as Acting Iroquois County Engineer

WHEREAS: a vacancy existed on April 21, 2023 in the office of the County Engineer in Iroquois County, Illinois due the untimely death of the incumbent County Engineer Joel V Moore which occurred on April 21, 2023, and

WHEREAS: the Iroquois County Board, due to this emergency, did on April 30, 2023 appoint Gregory L Perkinson, the current Ford County Engineer as the Acting Iroquois County Engineer.

WHEREAS: The continuing resolution 24-06 approving Gregory L Perkinson as the acting Iroquois County Engineer expires on February 28, 2024 it will be necessary to extend the acting county engineer appointment.

THEREFORE: Gregory L Perkinson will continue to serve as the Ford County Engineer, as of February 28, 2024 his salary paid by both Ford and Iroquois counties. His Ford County hourly rate will be \$38.90 per hour.

WHEREAS: the Iroquois County Board will continue to search for a permanent County Engineer, this agreement will terminate when the permanent Iroquois County Engineer is appointed. RESOLUTION 24 -

Resolution- Ford County Declares it is a NON-Sanctuary County for Immigrants

WHEREAS Article I, section 8 of the United States Constitution gives Congress the power to establish a uniform rule of naturalization, and;

WHEREAS it is the duty of Congress to establish all laws and rules regarding naturalization, and;

WHEREAS the 14th Amendment to the United States Constitution was ratified on July 9, 1869, and granted citizenship to "all persons born or naturalized in the United States" are citizens of the United States and of the State wherein they reside, and;

WHEREAS local law enforcement in Illinois is dedicated to protecting the communities they serve and promoting public safety requires the assistance and cooperation of the community, so law enforcement has the ability to gather the information necessity to solve and deter crime, and;

WHEREAS the trust of residents is crucial to ensure that they report crimes, provide witness statements, cooperate with law enforcement and feel comfortable seeking help when they are concerned about their safety, and;

WHEREAS Illinois law enforcement is governed by the 2017 Illinois Trust Act, which helps bolster cooperation with communities and confirms that law enforcement entities in Illinois are largely prohibited from participating in immigration enforcement operations thus declaring Illinois a "Sanctuary State" for immigration, and;

WHEREAS local law enforcement may not enter into immigration enforcement agreements with federal immigration authorities, and;

WHEREAS there is no express or inherent authority under Illinois law that permits state or local law enforcement to enforce federal immigration law, and;

WHEREAS local law enforcement may not stop, arrest search or detain an individual on the sole basis that they are undocumented, and;

WHEREAS only federal officers have the authority to arrest an individual for violation of civil immigration law without a criminal arrest, and;

WHEREAS Illinois cities, such as Chicago have declared themselves a "SANCTUARY CITY" by passing their "Welcoming City Ordinance" in 2021 protecting undocumented immigrants and refugees, and;

WHEREAS the volume of asylum seekers in voluntary Sanctuary Cities are reportedly overwhelming social service agencies and straining community resources, and;

WHEREAS those who enter the country illegally create the greatest burden on those who have entered legally often competing for the same jobs and opportunities

WHEREAS Ford County recognizes the humanitarian plight of those seeking refuge and asylum from oppressive governments in other parts of the world, and;

WHEREAS the federal government's refusal to enforce said immigration laws empowers drug cartels and victimizes women and children and often results in the exploitation of migrants, many of which have not filed asylum applications and are currently unaccounted for; and

WHEREAS Ford County respects the history of the United States as a beacon of freedom and opportunity, and;

WHEREAS Ford County recognizes and supports legal immigration through the proper channels of government, and;

WHEREAS Ford County supports the Sheriff's Office to uphold the law, federal immigration policy, and to protect and preserve public safety in our community

WHEREAS those who pay taxes and follow the laws of the land have been unfairly exploited and burdened by those who do not pay taxes and choose not to follow the laws of the land, and;

WHEREAS Ford County supports and upholds the rights of those legally in our communities and currently paying taxes to support the services we provide to our community, and;

WHEREAS Ford County by declaring itself a NON-SANCTUARY COUNTY pledges and rededicates its limited resources to its residents in need: Seniors, families living below the poverty level, veterans, and all those in need of Social Services already here in Ford County,

NOW THERFORE, BE IT RESOLVED BY THE COUNTY OF FORD, ILLINOIS, unit of local government by and through the Ford County Board that we declare ourselves a NON-SANCTUARY COUNTY for IMMIGRATION, dedicating our <u>limited resources</u> to all those already in need here in Ford County.
