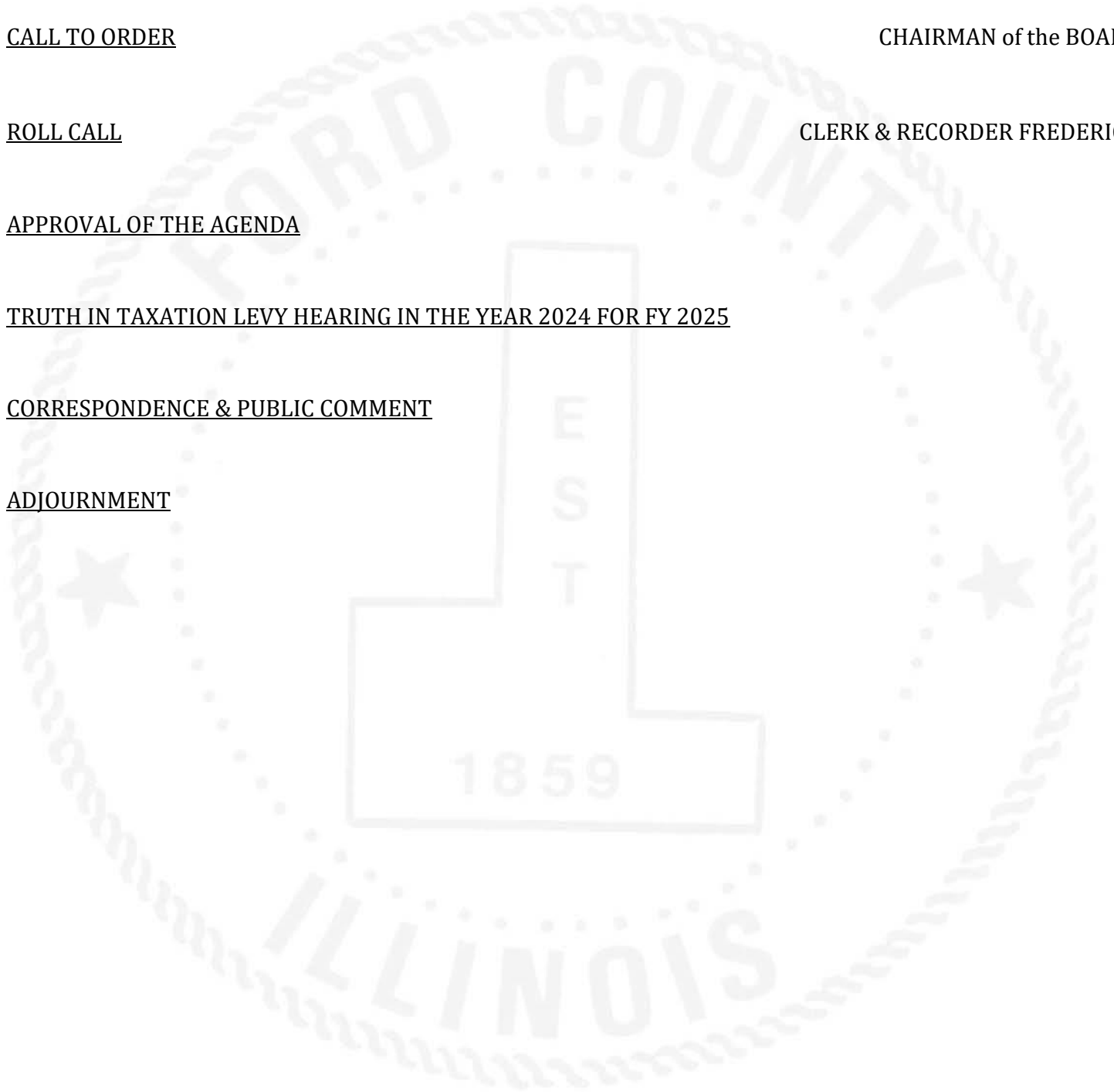

## **Notice of Property Tax Increase for Ford County**

- I. A public hearing to approve a proposed property tax levy increase for Ford County for year 2024 (FY 2025) will be held on Tuesday, December 10, 2024 at 6:30 p.m. at the Sheriff's Board Room, 235 N. American St., Paxton, Illinois 60957.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Amy Frederick, Ford County Clerk & Recorder, 200 W. State St., Room 101, Paxton, Illinois 60957, Phone: (217) 379-9400.

- II. The corporate and special purpose property taxes extended or abated for year 2023 (FY 2024) were \$3,896,530.08.

The proposed corporate and special purpose property taxes levied for year 2024 (FY 2025) are \$4,695,850.00. This represents a 20.5136% increase over the previous year.

- III. The property taxes extended for debt services and public building commission leases for year 2023 (FY 2024) were \$354,296.58.

The estimated property taxes to be levied for debt services and public Building commission leases for year 2024 (FY 2025) are \$296,000.00. This represents a -16.4541% decrease under the previous year.

- IV. The total property taxes extended or abated for year 2023 (FY 2024) were \$4,250,826.66.

The estimated total property taxes to be levied for 2024 (FY 2025) are \$4,991,850.00. This is a 17.4324% increase over the previous year.
